KidsQue Registration form

Rules and Regulations:

If you are competing in the Pikes Peak BBQ Showdown your child's entry fee is waived. If you are not competing in the Pikes Peak BBQ Showdown there is a \$5.00 entry fee per contestant. The KidsQue competition is for children of 6 to 13 years of age. If a child entered is found to be older than 13, they will be disqualified and forfeit their prize to the runner up. Parents or Guardians are allowed to, and encouraged to assist each competitor with the handling of fire (stacking coals, lighting coals), sharp objects (knives, probes, etc.) and with proper meat handling techniques such as showing them how to wash hands, put on sterile gloves and wash utensils thoroughly. Parents and Guardians are **NOT** allowed to help with the seasoning or prepping of the meats (other than trimming) to be cooked. Parents and Guardians are not allowed to put meats on or pull meats off the competitor's grill. If a parent or guardian is suspected of assisting in more than the handling of fire and sharp objects, that competitor is disqualified and prize will be forfeited to the next competitor. Competitors must season and cook their meats themselves, this includes putting meat on and taking meat off of the grill. Meats are required to be cooked to a safe done temperature before serving to the judges.

A safe done temperature for steaks are in the range of **135 F- 164 F Done Temp.**

There is a \$50.00 prize for whichever contestant takes first place

I understand, appreciate and acknowledge that property damage and injuries are common to such events. I fully assume the risk of such property damage and injuries to myself and my child that we participate in this voluntarily and with my full knowledge of the inherent risks.
